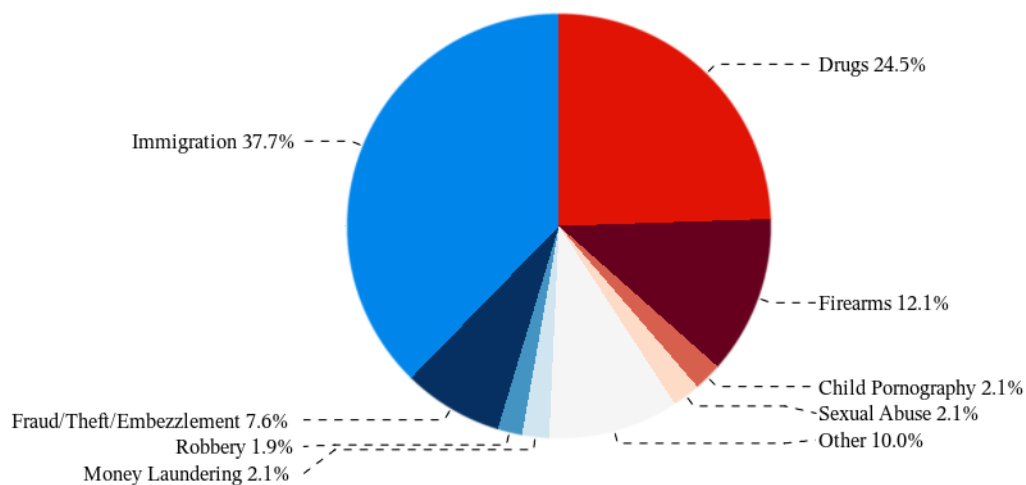

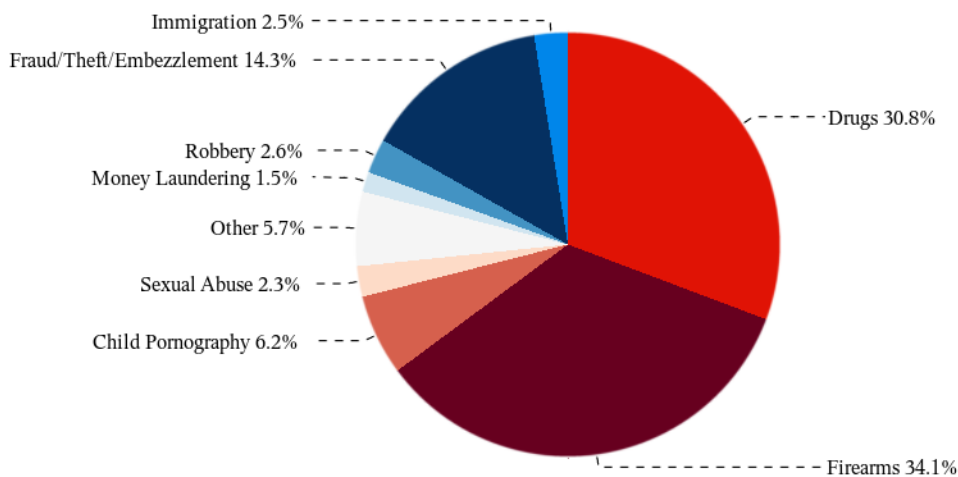

The Eastern District of Missouri figure includes the 988 cases reported to the Commission.

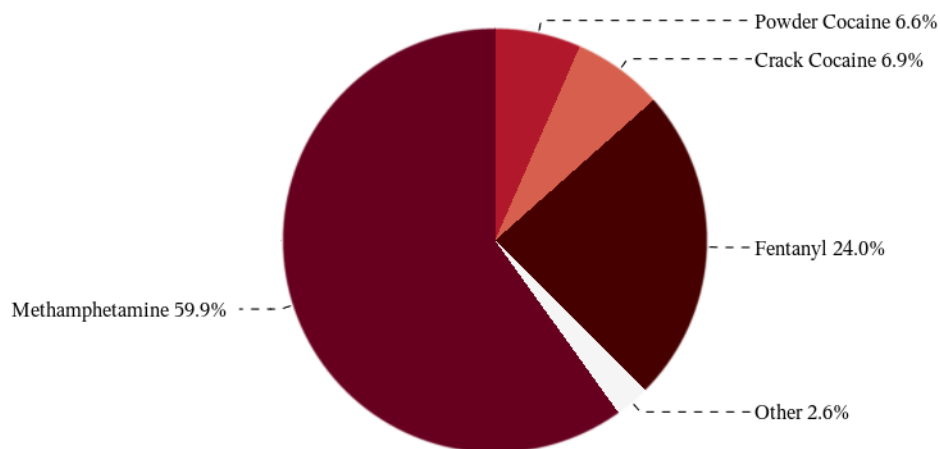
