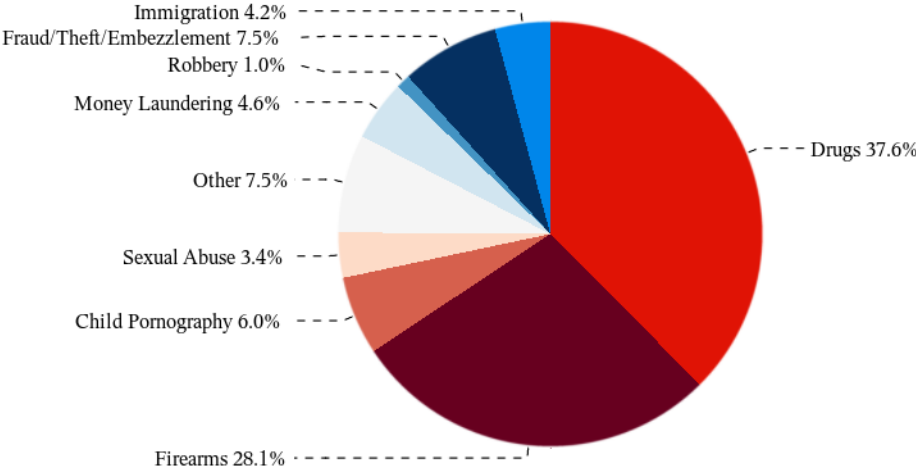

The Western District of Missouri figure includes the 668 cases reported to the Commission.

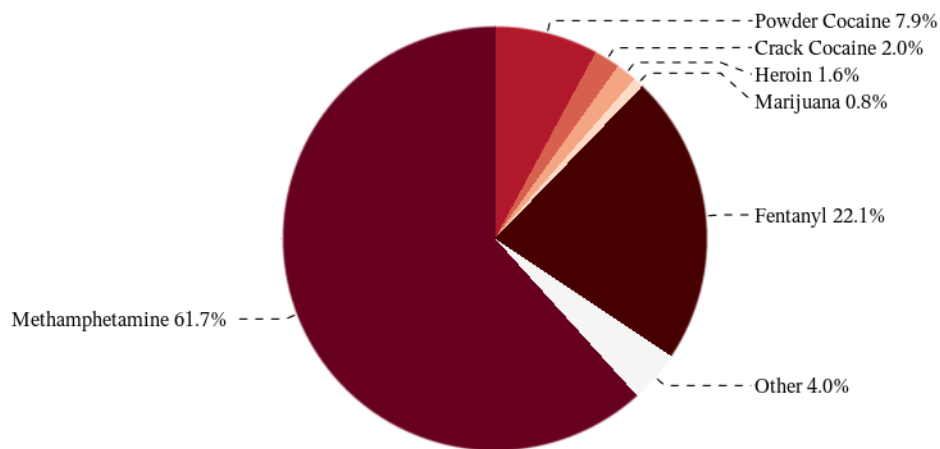
