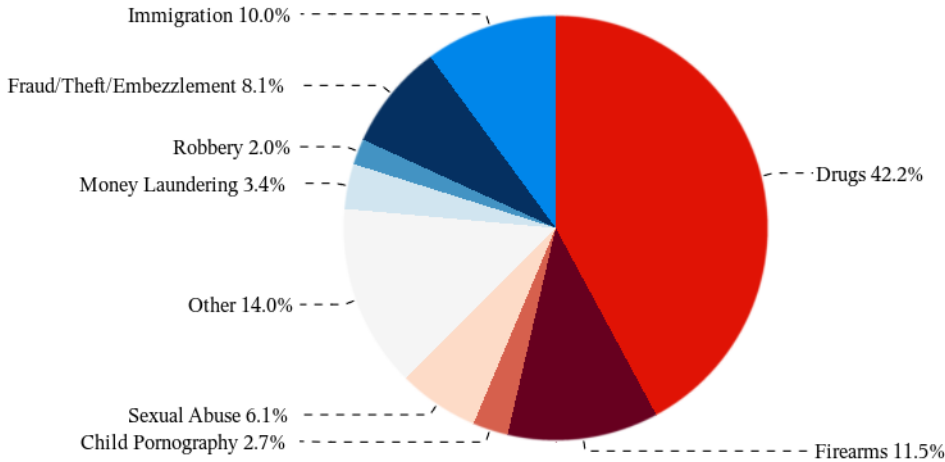

The Middle District of Pennsylvania figure includes the 408 cases reported to the Commission.

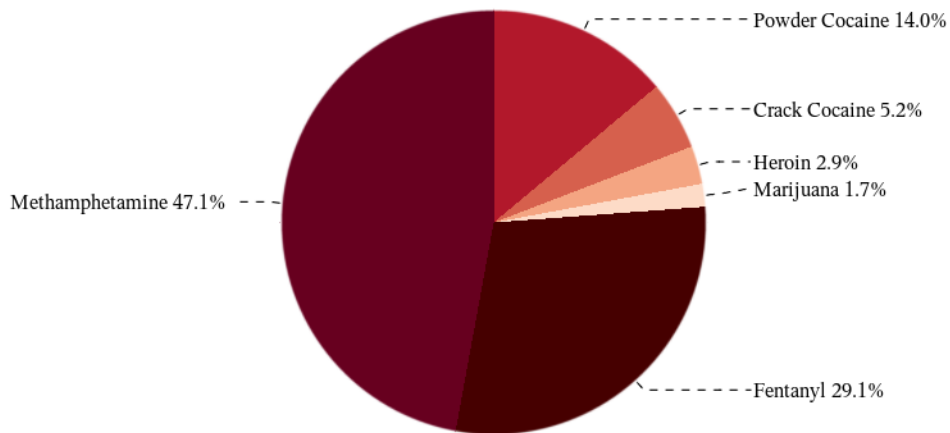

Of the 66,662 National cases, a U.S. Citizen was the sentenced individual in 37,373 cases. Of these, 33,403 cases were excluded because the sentenced individual was ineligible for a non-prison sentence.

Of the 408 cases from the Middle District of Pennsylvania, a U.S. Citizen was the sentenced individual in 338 cases. Of these, 316 cases were excluded because the sentenced individual was ineligible for a non-prison sentence.
