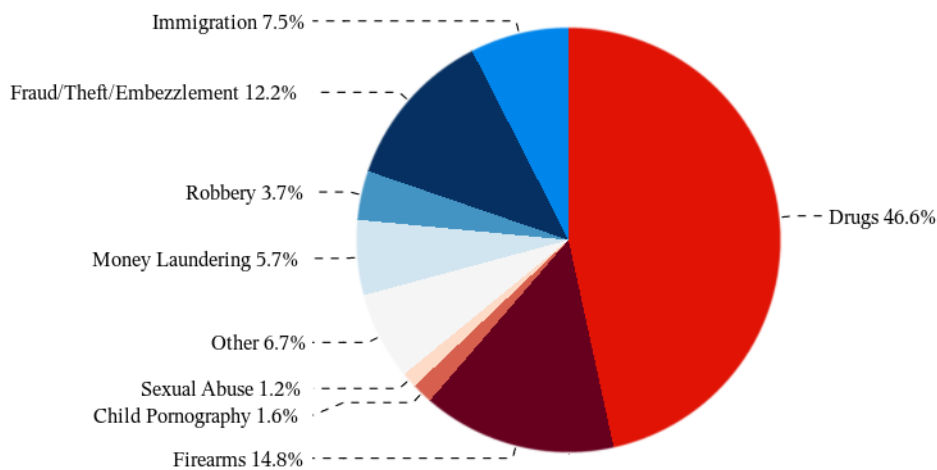

**Eastern Texas**



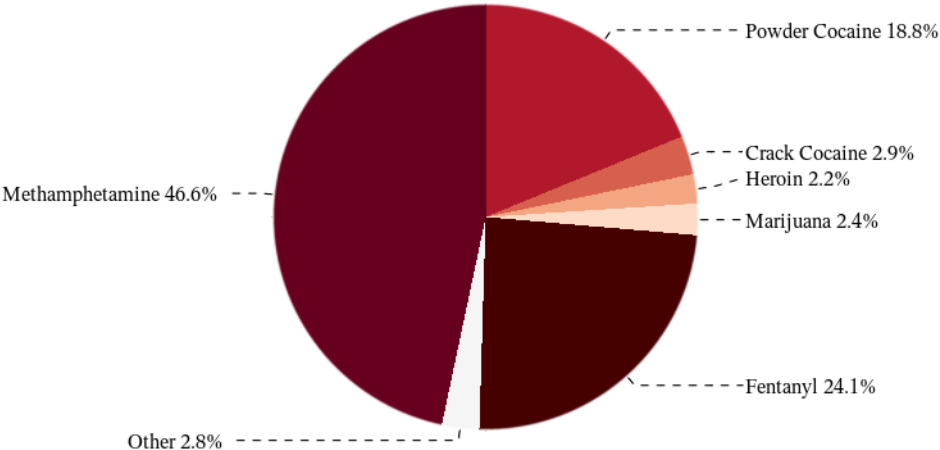

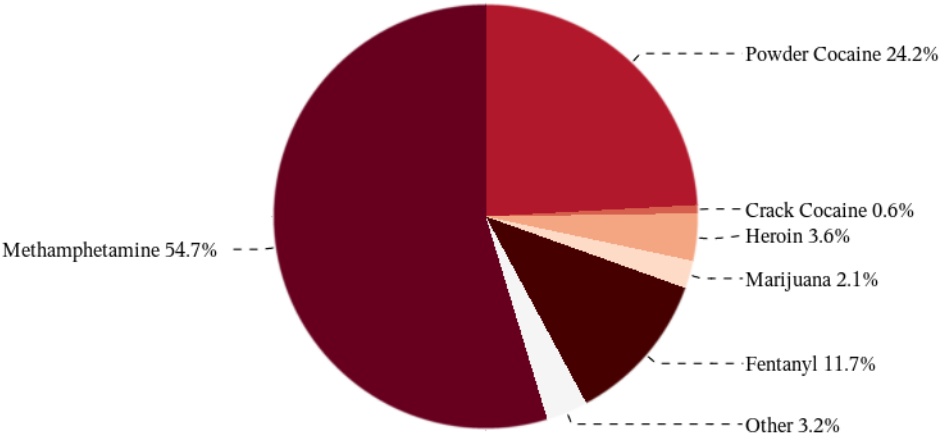
