- ► OF THESE CASES, 19,330 INVOLVED IMMIGRATION OFFENSES.¹
- ▶ 14.1% OF IMMIGRATION CASES INVOLVED ALIEN SMUGGLING. ²

Quick Facts

Alien Smuggling Offenses

In fiscal year 2017, there were 2,733 offenders convicted of alien smuggling, accounting for 14.1% of all immigration offenders sentenced under the guidelines. In 9.1% of alien smuggling cases, an unaccompanied minor was smuggled.


Offender and Offense Characteristics

- In fiscal year 2017, almost two-thirds (63.4%) of alien smuggling offenders were U.S. citizens.
- Most alien smuggling offenders were men (76.8%).
- The average age of these offenders at sentencing was 33 years.
- Over one-half (58.7%) of alien smuggling offenders had little or no prior criminal history (*i.e.*, assigned to Criminal History Category I). The proportion of alien smuggling offenders in other Criminal History Categories was as follows:
 - ♦ 13.6% of these offenders were in Category II;
 - ♦ 14.4% were in Category III:
 - ♦ 6.6% were in Category IV;
 - ♦ 3.9% were in Category V; and
 - ♦ 2.8% were in Category VI.
- Over half (51.9%) of alien smuggling offenses involved the smuggling, transporting, or harboring of fewer than six persons.
- Sentences were increased for 9.1% of offenders because one of the persons smuggled was an unaccompanied minor.
- An alien was involuntarily detained through coercion, threat, or in connection with a demand for payment in 1.0% of alien smuggling offenses.
- Most alien smuggling cases did not involve the use of weapons (97.0%).
- Although the majority of alien smuggling cases did not involve physical injury (97.6%), 32.4% of all alien smuggling cases involved the risk of injury.
- One or more aliens died in 0.6% of alien smuggling cases.

Punishment

- The majority of alien smuggling offenders were sentenced to imprisonment (88.7%).
- The average sentence length for alien smuggling offenders was 16 months.
- Although some alien smuggling offenses do carry mandatory minimum penalties, most alien smuggling offenders were not convicted of an offense carrying a mandatory minimum penalty (98.4%).

Number of Alien Smuggling Offenders






Sentences Relative to the Guideline Range


- The percentage of alien smuggling offenders sentenced within the guideline range decreased from 43.8% in fiscal year 2013 to 38.3% in fiscal year 2015, but increased to 44.5% in fiscal year 2017.
- The percentage of alien smuggling offenders who received a sentence below the applicable guideline range because the government sponsored the below range sentence steadily increased from fiscal year 2013 (42.7%) to fiscal year 2015 (48.6%), but has decreased since (41.1% in fiscal year 2017).
 - Substantial assistance departures were granted in 5.2% of cases involving alien smuggling.
 - These offenders received an average reduction of approximately half (51.4%) off their sentence.
 - ◆ Early Disposition Program (EDP)³ departures applied in 32.7% of alien smuggling cases.
 - These offenders received an average reduction of 40.8% in their sentence.
- The rate of non-government sponsored below range sentences for alien smuggling offenders increased from 9.9% in fiscal year 2013 to 12.6% in fiscal year 2017.
 - ♦ These offenders received an average reduction of about half off their sentence (46.3%) in fiscal year 2017.
- The average sentence and the average guideline minimum for alien smuggling offenses have remained constant over the last five years.
 - ♦ The average sentence was 17 months in fiscal year 2013 and 16 months in fiscal year 2017;
 - The average guideline minimum was 20 months in fiscal year 2013 and 19 months in fiscal year 2017.


Sentence Relative to the Guideline Range
