- THERE WERE 66,873 CASES REPORTED TO THE UNITED STATES SENTENCING COMMISSION IN FISCAL YEAR 2017.
- OF THESE CASES, 238 INVOLVED COUNTERFEITING BEARER OBLIGATIONS OF THE UNITED STATES.¹
- ► THESE OFFENDERS WERE SENTENCED UNDER SECTION 2B5.1 OF THE U.S. SENTENCING COMMISSION'S GUIDELINES MANUAL.


Counterfeiting Offenses¹

In fiscal year 2017, there were 238 counterfeiting offenders, who accounted for 0.4% of all offenders sentenced under the guidelines.² The number of counterfeiting offenders has decreased during the last five years.

Offender and Offense Characteristics

- In fiscal year 2017, the majority of counterfeiting offenders were men (81.9%).
- White offenders accounted for the largest group (39.7%) of counterfeiting offenders followed by Black (35.4%), Hispanic (20.3%), and Other Races (4.6%).
- The average age of these offenders at sentencing was 34 years.
- The majority of all counterfeiting offenders were United States citizens (86.6%).
- The most common Criminal History Category for counterfeiting offenders was Category I (30.3%). The proportion of these offenders in other Criminal History Categories was as follows:
 - ♦ 11.8% were in Category II;
 - ♦ 19.3% were in Category III;
 - ♦ 10.5% were in Category IV;
 - ♦ 11.8% were in Category V; and
 - ♦ 16.4% were in Category VI.
- The median face value of counterfeit items for these offenses was \$5,060.3
 - 84.3% of counterfeiting offenses involved items with a face value of \$40,000 or less.
 - ♦ 55.0% of counterfeiting offenses involved items with a face value of \$6,500 or less.
- Sentences for counterfeiting offenders were increased for:
 - 55.0% of offenders for manufacturing or producing counterfeit obligations or possessing counterfeiting paper, altered currency paper, or a counterfeit deterrent;
 - ♦ 11.8% of offenders for committing any part of the offense outside of the United States;
 - ♦ 5.9% of offenders for having a leadership or supervisory role in the offense;
 - ♦ 2.5% of offenders for possessing a firearm or other dangerous weapon in connection with the offense; and
 - 0.8% of offenders for obstructing or impeding the administration of justice.
- Sentences for counterfeiting offenders were decreased for:
 - ♦ 5.0% of offenders because they were a minor or minimal participant in the offense.

Punishment


- The majority of counterfeiting offenders were sentenced to imprisonment (88.2%).
- The average sentence length for counterfeiting offenders was 16 months.

Sentences Relative to the Guideline Range


- In each of the past five years, more than half of counterfeiting offenders were sentenced within the guideline range. In fiscal year 2017, 55.0% of counterfeiting offenders were sentenced within the guideline range.
- In each of the past five years, approximately 13 to 18 percent of counterfeiting offenders received a sentence below the applicable guideline range because the government sponsored the below range sentence.
 - Substantial assistance departures were granted in approximately five to 11 percent of counterfeiting cases in each of the past five years.
 - ♦ The average reduction for these offenders was 56.4% during the fiveyear time period (which corresponds to an average reduction of ten months).
 - Other government sponsored departures were granted in approximately four to nine percent of counterfeiting cases in each of the past five years.
 - ♦ The average reduction for these offenders was 55.4% during the fiveyear time period (which corresponds to an average reduction of 12 months).
- The rate of non-government sponsored below range sentences was approximately 21 to 29 percent in each of the past five years.
 - ◆ The average reduction for these offenders was 53.2% during the five-year time period (which corresponds to an average reduction of ten months).
- Both the average sentence and the average guideline minimum for counterfeiting offenders have increased slightly during the last five years.
 - ♦ The average guideline minimum increased from 17 to 21 months during that time period;
 - ♦ The average sentence imposed increased from 15 to 16 months during that time period.

Sentence Relative to the Guideline Range




Government Sponsored Below Range Sentences FY 2017
