


If a defendant qualifies for the safety valve under the statute, the defendant also automatically qualifies for a two-level reduction at §2D1.1.




Who resolves disputed sentencing issues and when are the issues to be resolved?




The TOR was created by the U.S. Navy Research Laboratory to help protect U.S. intelligence communications.
